## **Creating Strong Futures: Supporting Youth through Study Buddies**

For as long as she can remember, connecting with community and volunteering have been part of Susan's life. As a life-long Human Resources professional, she is passionate about making sure people are treated fairly. "I have always wanted to change the world and make it better, so now I get to do that every week by showing up at CommonBond," she says.

When Susan's daughter was young, she jumped in eagerly and often to support the school. When her daughter moved out, Susan connected with a new volunteer experience: the Study Buddies program at CommonBond. This unique program matches adult volunteers with an elementary school student to help them with literacy improvement and academic growth.

Susan has been volunteering as a Study Buddy at Torre De San Miguel in Saint Paul for five years. For three years, Susan has been working with the same student. They've been through the pandemic together, working in a virtual environment, and can now be in person. At CommonBond, we are focused on providing wraparound services that help the youth of tomorrow flourish — not just in academics but in all areas of their lives moving forward.

## **Building Stable Homes: Construction Snapshot**



Our Acquisition and Development Team had a busy year!

In 2022 we improved or built **4** new-construction housing communities, providing **282** new homes.

### **Properties Coming Soon:**



RISE ON 7

ST. LOUIS PARK, MINNESOTA

Rise on 7 will offer 120 units of new-construction affordable housing and a ground-floor commercial space reserved for Rise Early Learning. Rise Early Learning, in collaboration with Way to Grow, will provide on-site childcare and early learning programs for families at Rise on 7 as well as community members. Additionally, six units will be reserved for individuals experiencing homelessness.

#### THE RADIANT

RAPID CITY, SOUTH DAKOTA



The Radiant will provide 42 units of new-construction housing for families, comprised of 30 affordable units and 12 market rate units. The site is CommonBond's first in South Dakota and will offer much-needed affordable housing in Rapid City.



THE LUMIN

SAINT PAUL, MINNESOTA

The Lumin will provide 60 units of housing for seniors in the Highland Bridge development in Saint Paul. Residents will be people ages 62 and older who earn 30 percent or less of the Area Median Income (AMI). Seven units will be reserved for formerly homeless seniors.



### MARKETPLACE CROSSING

BIG LAKE, MINNESOTA

Marketplace Crossing will provide 60 units of housing in the Northwest Twin Cities suburb of Big Lake. This project will provide high quality, new-construction affordable housing in a growing suburban community in the I-94 corridor. Six units will be reserved for persons with disabilities and seven for formerly homeless individuals.
