Keeping Homes Affordable for Years to Come

Tax Credit Program Key to Preservation

While we need to build new homes, it is equally important to invest in our existing housing communities.

In 2023 the **Minnesota State Housing Tax Credit Program** was created, giving taxpayers the ability to support affordable housing communities.



CommonBond community Wilder Square

CommonBond's Wilder Square, Bloomington Family Townhomes, and St. Anne's Senior Housing have already benefited.

At Wilder Square, the average household income is \$19,000. Without many housing options in the area, residents are at risk

of homelessness. With CommonBond, not only do they have a stable home, but they also have access to our signature wraparound Advantage Services.

One resident and mother of two children lost her job and needed help finding a new one. Advantage Services staff met with her regularly and helped her get a new full-time position.

Stories like this are only possible because we have

Since CommonBond's recent reimagining of our wraparound Advantage Services, more and

more residents have been able to access these lifeenhancing resources.

The Radiant community itself has been transformative for Lorraine, even as someone who calls herself "stubbornly independent." She says, "Living here has been an education for me. Now, I have staff and neighbors to help with everything. I'm suddenly living in this big family." *

- Includes 96 units across six buildings
- Began December 2024 with projected completion of December 2025
- Will add 15-20 years of economic life to the building
- Rehabs like this are an important way to sustain affordability and improve living spaces
